NOMINATIONS

Listed below is Section I, II, and III of Article IX of Suncoast Florida Region Bylaws:

Art. IX Election of Officers

Sec. I Nominating Committee

Not later than September 1 of each year, the President shall appoint a Nominating Committee of three members. The Nominating Committee shall submit a slate of candidates for those offices to be vacated at the December meeting. The Nominating Committee shall present its slate of candidates at the October meeting. No person may be nominated without his permission.

Sec. II Nominations by Members

At the October meeting, members in good standing may nominate candidates for offices to be vacated at the December meeting, from the floor. No member may be nominated without his permission. If a nomination is made from the floor, the member making the nomination must present evidence that the nominee has given his permission to be nominated. Such evidence shall be in writing if the nominee is not present at the meeting.

Sec. III Voting

The Secretary shall prepare a written ballot listing the names of all the nominees to the offices to be vacated at the December meeting. Such ballot shall be included in the November Profile. Members may vote either by mail prior to the November meeting or in person at the November meeting. Election shall be by a simple majority of those voting. The Secretary shall publish the results of the election in the December Profile.

In accordance with the above, I have selected Brooke Ballagh, Fran Huffman and Stu Rappaport to serve as the Nominating Committee.

It is important that we, as members of the Region, in order to endure and remain fresh in our thinking and activities, consider and select nominees who recognize the general objectives of the Suncoast Region and the Porsche Club of America. Newer members as well as old-time members have a place as officers and board members.

However, it should and must be understood that when a person makes an obligation to the Region, he or she does so to uplift the Club and help it to grow. Just as the 356 progresses to the current level of sophistication of the 928 thru the growing steps of the 914, 924, and 911, we as a Region must do so by using our members as stepping stones.

If you would like to be an exciting part of a growing Region and will accept the responsibility, contact me or the Nominating Committee.

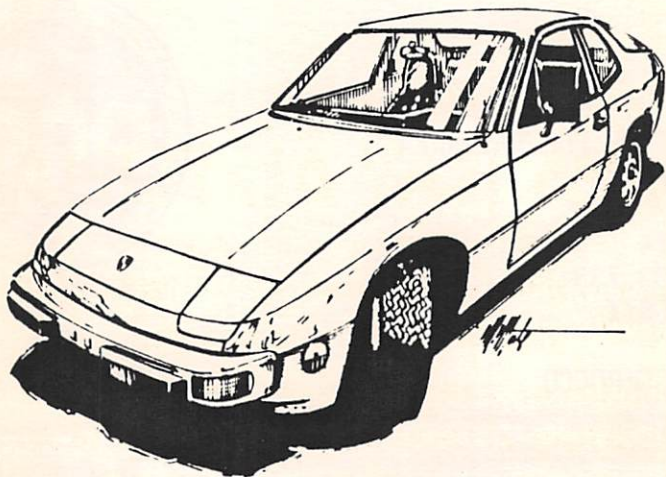
